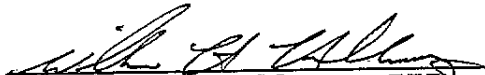

The undersigned incorporator(s) hereby forms a corporation under Chapter 621 of the laws of the State of Florida.

ARTICLE I

NAME

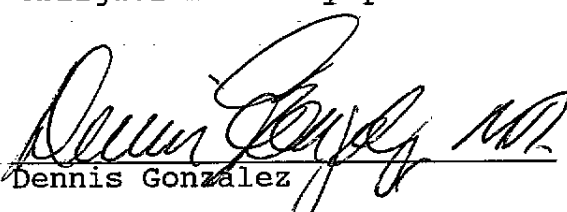
