



ARTICLES OF INCORPORATION OF AQUATAT, INC.

The undersigned, acting as the sole incorporator under the Florida General Corporation Act, adopts the following Articles of Incorporation:


1. **NAME.** The name of this corporation is AQUATAT, INC.


