Dear Sir or Madam,

This is in regard to the delinquent filing of our 2000 Uniform Business Report (enclosed, with our check for \$150).

We apologize for this delinquent filing, yet the circumstances that lead to it were beyond our control.

We incorporated in late July of 1999 and began operations in August 1999. As such, we were not aware of (and did not receive) the 1999 UBR filing. We suspect that the reason we did not receive the original (first notice) UBR earlier this year may have something to do with the registered agent (Filings, Inc.) being located in Fort Lauderdale, some 450 miles away. Another possible factor may have been the misspelling of our street address (Gunn Highway, spelled G-u-n on the UBR). Another error in the UBR, while not affecting the delivery of same, is the misspelling of both my last name and the company name ("Muilli" as opposed to the correct "Miulli").

Moreover, neither the attorney who incorporated us (Joe Davis) nor our registered agent (Filings, Inc.) notified us of the UBR requirement or the associated fees and penalties.

While our new accounting firm recently notified us of the UBR filing requirement, it was the first we had heard of it.

To avoid these problems in the future, we have noted corrections on the enclosed UBR to correct the misspellings and to change the registered agent to our current accounting firm.

As the result of these events, we respectfully request that you abate the late fees and accept the enclosed check in payment of our 2000 UBR fee.
