THE UNDERSIGNED, MERCELY DEVABAVUS being the sole Director, President and Secretary of TRINITY MEDICAL & VASCULAR CLINIC, P.A., does hereby certify that the following Amendment to the Articles of Incorporation of TRINITY MEDICAL & VASCULAR CLINIC, P.A. was approved by the Stockholders of said Corporation on the 9th day of June, 2003, at a duly called meeting of the Stockholders and Directors of the Corporation.

The Articles of Incorporation of TRINITY MEDICAL & VASCULAR CLINIC, P.A. are hereby amended as follows:

- 1. Article I is hereby deleted and the following is inserted in lieu thereof:

ARTICLE I

- 1. The name of the Corporation shall be **TRINITY MEDICAL CLINIC, P.A.**
- 2. All amendments included herein were adopted effective June 9, 2003 pursuant to Section 607.1004, F.S., and there is no discrepancy between the Corporation's Articles of Incorporation as theretofore amended other than the inclusion of these amendments and the omission of matters of historical interest.
- 3. This Amendment has been approved by unanimous consent of all of the Shareholders of the Corporation who are entitled to vote effective June 9, 2003.
- 4. This Amendment shall be effective upon its filing with the Secretary of State, State of Florida.
