

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I -- NAME

The name of the corporation shall be THE NAGY CORPORATION, INC.

ARTICLE II -- NATURE OF BUSINESS

1. The general nature of the business of the corporation shall be the purchase and sale of miscellaneous goods and any other lawful business.




