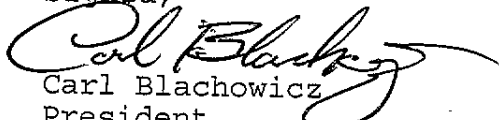

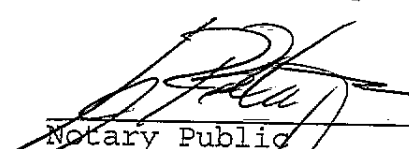

## ARTICLES OF INCORPORATION

THE UNDERSIGNED, for the purpose of forming a Corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation.

### ARTICLE I NAME -----

### ARTICLE II PRINCIPAL OFFICE -----

The duration of the Corporation is perpetual.
