**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of RODRICKS DEVELOPMENT CORP. under the Florida Business Corporation Act, adopts the following articles of incorporation.

**ARTICLE I - NAME**

**ARTICLE IV - PURPOSE**

## **ARTICLE V - AUTHORIZED SHARES**

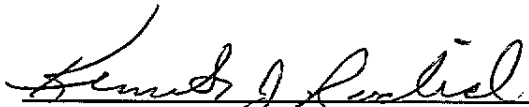
## **ARTICLE IX - BYLAWS**

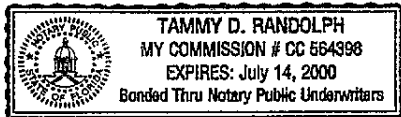

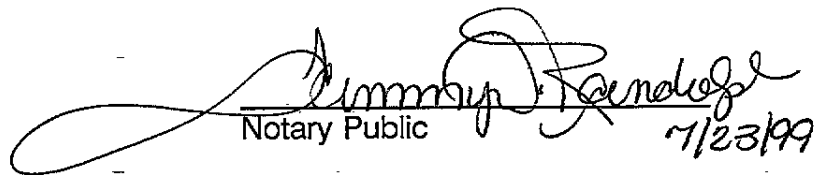

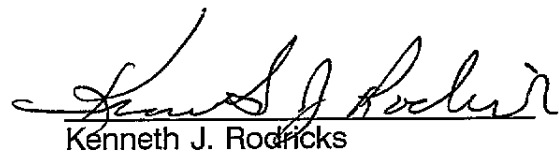
