ARTICLES OF INCORPORATION
OF
THE DREAM PLAN NETWORK, INC.

The undersigned, acting as the Incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation is **THE DREAM PLAN NETWORK, INC.**

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The purposes for which the corporation is organized are to engage in the wholesale and retail sale of architectural plans and in any activity or business permitted under the laws of the United States and Florida.

ARTICLE IV

Authorized shares

Number: The aggregate number of shares that the corporation shall have the authority to issue is 10,000 shares of Class A Common Stock.

Voting Rights: Each share of Class A Common Stock will entitle the holder to 1 vote per share.

Par Value: Each share shall have a stated par value of \$1.00.
