**Re: Southern Supply of Pinellas, Inc./Application for Reinstatement and
Request for Waiver of Reinstatement Fee**

Dear Sir or Madam:

Our firm represents Southern Supply of Pinellas, Inc., a Florida corporation which was administratively dissolved in September, 2000 for failure to file its Uniform Business Report ("UBR").

Enclosed are the following:

- 1) Application for Reinstatement, and
- 2) Check for \$308.75 payable to the Department of State for the 2000 and 2001 UBR's and a certificate of status.

We respectfully request a waiver of the \$600.00 reinstatement fee. It appears that both the principal address and the mailing address of the corporation were incorrectly entered in the Secretary of State's records when the Articles of Incorporation were filed in 1999. A copy of the filed Articles is enclosed for your information. The last Article (Article XIII) provides that the initial mailing address was 1501 Burlington Avenue North, St. Petersburg, FL 33705; however, this information was apparently entered by the filing department as 1501 Burlington Avenue North, Sarasota, FL 34237.

As a result of the error, the corporation did not receive its 2000 or 2001 UBR's. The error was not discovered until recently when we were reviewing our file on the corporation.

As noted on the reinstatement form, the corporation's mailing address is now P.O. Box 1239, Sarasota, FL 34230.
