ARTICLE I.

The name of this corporation shall be:

ARTICLE II.

The duration of the Corporation shall be: PERPETUAL.

ARTICLE III.

NATURE OF CORPORATE BUSINESS:

This Corporation may engage in any international and domestic activity or business permitted under the laws of the United States of America and under the laws of the State of Florida.

ARTICLE IV.

CAPITAL STOCK:

This Corporation is authorized to issue a maximum of One Hundred (100) shares of stock at this time. The shares of stock authorized shall be common stock having a par value of One Dollar (\$1.00) per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors. No preemptive right is to be granted to shareholders at this time.
