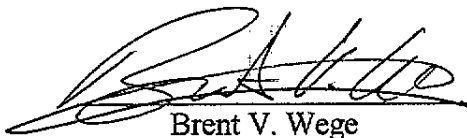

This is to certify that the undersigned, hereby associate themselves under the provisions of the laws of the state of Florida, with the intent to form a profit corporation.

ARTICLE I

The name of the corporation is **Intertech Systems of Broward, Inc.**

ARTICLE II

The existence of the corporation shall commence as of the date of filing. The Corporation shall be of perpetual existence.

ARTICLE III

The corporation may transact or engage in any or all lawful activities or business permitted under the laws of the United States, and the state of Florida or any other state.

ARTICLE IV

One thousand(1,000) shares will be the maximum number of shares that this corporation has authority to have outstanding at any one time. The par value of these shares will be set at \$1.00 each.

The above mentioned stock will be the only one(1) class of stock within the corporation, common stock. The stock will be partly issued in quantities to the undersigned subscriber(s).

The stockholders of the corporation shall manage the business and activities of the corporation, rather than by a board of directors.

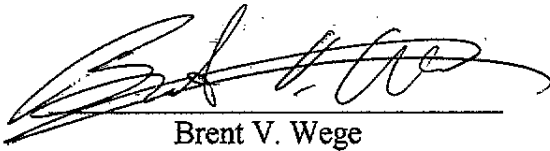
ARTICLE XI

Furthermore, preemptive rights shall be granted to each shareholder of any stock within this Corporation. These rights include the option to maintain the shareholders equal

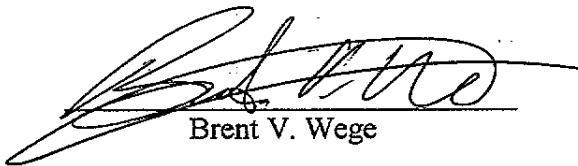
value within the corporation before the additional stock is sold to others. The
