I am in receipt of your letter dated July 13, 2001. However, I am bewildered again as I was last year at this time. Last year when I received your fee notice I called up the person that does my taxes and asked him about it, since this was the first time I have ever heard of the uniform business report. His reply was that you have to file every year and pay your corporation fee. I said no problem but I still didn't understand about the paper saying it was the second notice. He asked me if I had received any correspondence prior to this notice stated it was the first notice. I informed him this was the first time I had seen anything like this. I never received a first notice. He told me to go ahead and write a letter to the Division of Corporations and explain to them exactly what I told him and to include a check for \$150. I did as he requested and did not hear from the Division of Corporations again until the beginning of July this year. I assumed that when I sent it in last year I would receive my first notice this year in ample time to comply with the \$150 fee.

When I received my notice the week of July 2, 2001 which stated it was due September 12, 2001 I immediately sat down and filled out the papers and included my \$150 corporation fee. I then received your letter dated July 13, 2001 stated that I was late and had to send in an additional \$400. This was the first notice I received in 2001 about my uniform business report filing and the corporation fee. This is exactly the same thing that happen last year, I just don't understand it?

I immediately called the phone number included in your letter and explained the whole thing to one of your customer service personnel and she informed me to go ahead and write this letter explaining the whole thing to your Department.


