WHEREAS, pursuant to Article FIRST of Articles of Incorporation filed with the Secretary of State on the 30th day of July, 1999, Florida corporation document number P99000068173 was issued in the name of QuickStar, Inc., a Florida corporation ("Corporation"); and

WHEREAS, pursuant to Article SEVENTH of said Articles of Incorporation, a scrivener's error resulted in the address of the initial Director of the Board of Directors being described as "11712 - 8th Street North, Largo, FL 33773"; that further, such address is 11712 - 87th Street North, Largo, FL 33773;

WHEREAS, pursuant to Certificate Designating Place, Business or Domicile for the Service of Process Within This State, Naming Agent Upon Whom Process May be Served, a scrivener's error resulted in the address of the Corporation's designated location as "11712 - 8th Street North, Largo, FL 33773"; that further, such address is 11712 - 87th Street North, Largo, FL 33773.

WHEREAS, pursuant to Article TENTH of said Articles of Incorporation, the Corporation reserves the right to correct, amend or alter any provision of said Articles of Incorporation in the manner now or hereafter prescribed by statute and all rights conferred upon stockholders pursuant to said Articles of Incorporation were granted subject to such reservation; and

WHEREAS, all Shareholders and Directors of the Corporation desire to amend said Article Articles of Incorporation so as to correct said scrivener's errors;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. Effective upon filing of these Articles of Correction with the Secretary of State, State of Florida, Article SEVENTH of said Articles of Incorporation of the Corporation shall be corrected with the following address:

2. Effective upon filing of these Articles of Correction with the Secretary of State, State of Florida, the Corporation's designated location of its registered office shall be "11712 - 87th Street North, Largo, FL 33773."

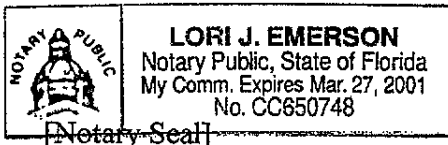

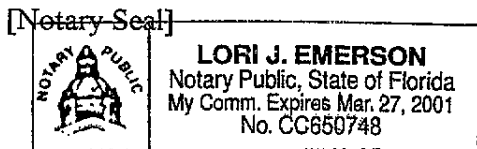
