**ARTICLE I.**

**CORPORATE NAME**

The name of this corporation is Johnston Properties of Southwest Florida, Inc..

**ARTICLE II.**

**ADDRESS OF CORPORATION**

**ARTICLE III.**

**DURATION**

The corporation shall have perpetual existence, commencing on the date of the execution and acknowledgment of these Articles or upon filing.

**ARTICLE IV.**

The corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE V.**

**NUMBER AND CLASS OF STOCK**

### ***BYLAWS***


The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors.



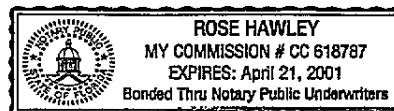
