ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of the captioned corporation under the Florida P.

Articles of Incorporation: Business Corporation Act, adopts the following Articles of Incorporation:

## **ARTICLE I**

# Corporate Name and Principal Office

#### **ARTICLE II**

## Commencement of Corporate Existence
