THE UNDERSIGNED Incorporator hereby makes, subscribes to, acknowledges and files these Articles of Amendment to the Articles of Incorporation of FRANCE TELEVISION, INC., and respectfully states:

1. The name of the Corporation is France Television, Inc., (the "Corporation") and the Corporation is filed under document number P99000068437.

2. This Amendment to the Articles of Incorporation was adopted on September 28, 1999, by the undersigned Incorporator, without shareholder action and shareholder action was not required for adoption.


3. Article 4 of the Articles of Incorporation is stricken in its entirety and restated as follows:

Article 4. The Corporation shall be authorized to issue 100 shares of Class A Common Voting Stock and 9,900 shares of Class B Non-Voting Common Stock, all at a .10 per share par value and the distinction between Class A Stock and Class B Stock shall met the definition of one class of stock described in Section 1361(c)(4), Internal Revenue Code of 1986, as amended.
