ARTICLES OF INCORPORATION OF

L & K of the PALM BEACHES, INC.

The undersigned, for the purposes of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name and Address. The name of the Corporation is: L & K of the PALM BEACHES, INC. The principal office and the mailing address of the Corporation is: 9337 Howell Lane, Palm Beach Gardens, Florida 33418.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

Article 4. Shares. The aggregate number of shares which the Corporation is authorized to issue is 100 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 (one dollar) per share.

Article 5. Initial Registered Office and Agent. The street address of the initial Registered Office of the Corporation is 9337 Howell Lane, Palm Beach Gardens, Florida 33418 and the name of its initial Registered Agent at that address is Leonard F. Schulz, Jr.

Article 6. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is 2 (two). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never by less than one.
