

## ARTICLES OF INCORPORATION

WEBCITE PROMOTIONS, INC.

### ARTICLE I

The name of this corporation shall be WEBCITE PROMOTIONS, INC..

### ARTICLE II

The purpose of this corporation shall be to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

### ARTICLE III

The term of this corporation shall be perpetual.

### ARTICLE IV

This corporation shall have the authority to issue 10,000 authorized shares of common stock of \$1.00 par value.

### ARTICLE V

This corporation shall have one director initially. The corporation is authorized to have as little as one (1) and as many as seven (7) Directors without amending the Articles of Incorporation. Members of the Board of Directors may participate in regular, special and annual meetings of the board of directors by means of conference telephone or similar communications equipment as provided by law, however upon notice by the Board of Directors, special meetings of the board of directors may require actual attendance in fact in person by each of the directors.


## INDEMNIFICATION
