Article I - Name

The name of this corporation is **F. A. HOVAN, INC.**

Article II - Duration

This corporation shall exist perpetually.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business, including, but not limited to, operating and managing a restaurant(s) and/or any other business related thereto for which corporations may be incorporated under the provisions of the Florida General Corporation Act.

Article IV - Capital Stock




