

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Barro-Tex USA, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 5500 Collins Avenue Miami Beach, Florida 33140

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK
