**ARTICLE V. TERM OF EXISTENCE**

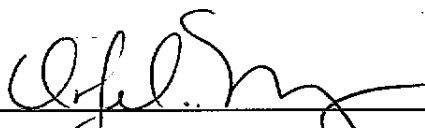
