ARTICLES OF INCORPORATION

OF

DOVE, INC.

The undersigned subscriber to these Articles of

Incorporation, a natural person competent to contract, hereby
forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is: DOVE, INC.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

The corporation is authorized to have outstanding one class of stock designated as common stock.
