OF

Article I

Name. The name of this Corporation is P & G CONTRACTORS, INC., and the principal office address of the corporation is HC 4, Box 4419, Satsuma, Florida 32189.

Article II



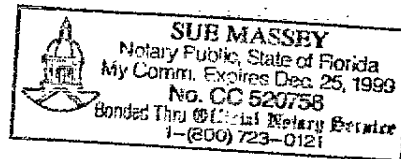
