ARTICLES OF INCORPORATION OF BUDDY JOYNER MASONRY, INC.

Article 1

Name. The name of this Corporation is BUDDY JOYNER MASONRY, INC.

Article II

<u>Principal Office</u>: The principal place of business and mailing address of this corporation shall be: 2025 North East 15th Terrace, Gainesville, Florida 32609.
