**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of 5-Year, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is:


ARTICLE IX: BYLAWS


