Enclosed is my Uniform Business Report for year 2001. I realize that it is filed after May 1 and the penalty should apply.

In early February of 2001 I mailed my corporate income tax records to my C.P.A., Mr. Robert Titus of Wall Foss Financial, LLC. I included all the forms and papers I had received which included the Uniform Business Report. I asked him to prepare thee forms and return them to me so that I could file all forms timely.

About a week ago I was told in a conversation about another matter: "It's after May 1, so that corporation will have filed its UBR and hopefully the state has updated its Internet site." I realized that my accountant had not yet sent me any such form to file. I called my accountant and asked him about the form. He told me that he hadn't yet even opened the package I mailed to him. I instructed him to mail me the UBR form immediately. I received the original blank UBR form in the mail from him this week.
