I did not receive the UBR form earlier in the year and did not realize that it was due until I received the later notice for the September 13th deadline. I spoke with my C.P.A. and he checked his records and was unable to find the earlier form. I have checked to be sure that the Department of State has the correct mailing address. The only other possibility is that when the earlier UBR was mailed it was placed in the wrong Post Office box since there are more than six other individuals/businesses in our area with the name Larkin. This is a regular occurrence in our Post Office. Unfortunately, not all of those individuals/businesses are kind enough to make sure that the mail gets back to the correct owner.

I respectfully request that you abate the additional penalty fee for filing after May 1st.
