ARTICLES OF INCORPORATION OF MACH 1 INVESTIGATIVE SERVICES, INC.



The undersigned, hereby associated together for the purpose of becoming a Corporation under the Laws of the State of Florida, F.S. 607, by and through the provisions of the Statutes of the State of Florida, providing for the formation, liabilities, rights, privileges, and immunities of corporations.

ARTICLE I

The name of the Corporation shall be:

MACH 1 INVESTIGATIVE SERVICES, INC.

Its principal place of business shall be located at 8107 NW 74th Avenue, Tamarac, FL 33321, or at such other places in the State of Florida, the United States or foreign countries as may, from time to time, be authorized by the Board of Directors.

ARTICLE II
