## ARTICLES OF INCORPORATION

### ARTICLE I - NAME

The name of this corporation is Express Tax Service, Inc.

### ARTICLE II - PRINCIPAL OFFICE

### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

### ARTICLE IV - CAPITAL STOCK
