ARTICLES OF INCORPORATION

OF

BLANCA LUNA, M.D., P.A.

The undersigned incorporator hereby forms a professional corporation under the Professional Service Corporation and Limited Liability Company Act, Florida Statutes, Chapter 621, and other laws of the State of Florida.

ARTICLE I - NAME

The name of the Corporation is Blanca Luna, M.D., P.A.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by the Corporation is to engage in every phase and aspect of the business of rendering the same professional services to the public that a medical doctor, under the laws of the State of Florida, is authorized to render, and to engage in any other acts that are permitted by law.

ARTICLE III - AUTHORIZED STOCK

The aggregate number of shares of stock that the Corporation is authorized to have outstanding at any one time is Five Thousand (5,000) shares of common stock having a par value of \$1.00 per share. None of such shares of the Corporation may be issued to anyone other than an individual duly licensed to practice medicine in the State of Florida.

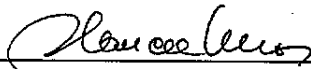
