ARTICLES OF INCORPORATION OF Q.T. MEDICAL SERVICES, INC.

The undersigned incorporator to these Articles of Incorporation hereby form a corporation under the laws of the State of Florida as follows:

ARTICLE I

Name and Address

The name of this Corporation Q.T. MEDICAL SERVICES, INC. The street address of the Corporation is: 334 East Lake Road, #308, Palm Harbor, Florida 34685.

ARTICLE II

Term of Existence

This Corporation shall have perpetual existence, commencing upon filing of these articles of incorporation with the Florida Secretary of State.

ARTICLE III

Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV

<u>Powers</u>

The Corporation shall have the power:

- (a) To have perpetual succession by its corporate name.
