ARTICLES OF INCORPORATION

OF_

Asthetic and Plastic Surgery Center of Jacksonville, P.A.

The undersigned incorporator, for the purpose of forming a professional association under the Professional Services Corporation Act, hereby adopts the following Articles of Incorporation.

Article I Name and Duration

The name of this professional association is Asthetic and Plastic Surgery Center of Jacksonville, P.A. The duration of the professional association is perpetual. The effective date upon which this professional association shall come into existence shall be the date these Articles are filed by the Secretary of State.

Article II Principal Office

Article IV Capital Stock

The maximum number of shares of stock which this professional association is authorized to have outstanding at any one time is one thousand (1,000) shares having \$.01 par value.

Article V Shareholder Restrictions

No one other than an individual who is duly licensed or legally authorized to render medical services in the State of Florida may own stock of this professional association. No sharcholder of this professional association shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of his stock. Any stockholder who becomes legally disqualified to render medical services shall sever all employment with and financial interest in the professional association. No shareholder shall transfer any shares of stock of the professional association, except to another individual who is eligible to be a shareholder of the professional association.

Article VI Registered Office and Agent

The street address of the registered office of this professional association is 50 North Laura Street, Suite 2750, Jacksonville, Florida 32202 and the name of the registered agent of this professional association at that address is MOTOLAW, Inc.

Article VII Directors

- 1. This professional association shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one (1). The manner of selection of directors shall be as provided in the bylaws.
- 2. The name and street address of the sole member of the initial board of directors of this professional association, who is licensed to practice medicine in the State of Florida, is:

3. If any vacancy occurs in the Board of Directors during a term, the remaining directors, by affirmative vote of a majority thereof, may elect a director to fill the vacancy until the next annual meeting of shareholders.

Article VIII Bylaws

The power to adopt, amend or repeal bylaws for the management of this professional association shall be vested in the Board of Directors or the shareholders, but the Board of Directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to the amendment or repeal by the Board of Directors.
