These Articles of Dissolution are filed pursuant to Florida Statute Section 607.1403, to reflect a dissolution of ASTHETIC AND PLASTIC SURGERY CENTER OF JACKSONVILLE, P.A., a Florida professional association (the "Corporation"), and in connection therewith, the undersigned officer, acting upon authority of the Board of Directors and the shareholders of the Corporation, hereby sets forth as follows:

1. The name of this corporation is ASTHETIC AND PLASTIC SURGERY CENTER OF JACKSONVILLE, P.A.
2. The Articles of Dissolution of the Corporation have been authorized and approved by the Board of Directors and Shareholders by unanimous written consent on 9-23, 1999. The number of votes cast by the Shareholders was sufficient for approval.
3. Upon the filing of these Articles of Dissolution by the Florida Secretary of State, the Corporation shall be deemed to be dissolved accordingly.
4. All known debts, liabilities, and obligations of the Corporation have been paid and discharged, or adequate provision has been made therefor.
