
Dear Sir or Madam:

Attached are the required UBR Forms for Trista C. Kuhn Accounting & Software Implementation Services Inc., EIN 59-3592139, Document # P99000069027 along with the Filing Fee of \$150. These forms are late due to extreme illness of myself, the President and only employee of said corporation. Due to a high risk pregnancy I was confined to my bed for several months and physically unable to complete the forms when the first notice to report was apparently sent to my corporation. I have not been able to locate that document and do not recall receiving it.

However, now I have received the second notice and upon reading the instructions realized that a \$400 late fee was assessed for not meeting the May 1, 2000 deadline of the first notice. As I incorporated in July of 1999, this is the first UBR I have been required to complete and was not previously advised to do so by my accountant or my attorney. Therefore, the second notice sent was the first time I became aware of such an obligation.
