ARTICLES OF INCORPORATION
OF
THE SPONSORSHIP NETWORK, Inc..

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:
THE SPONSORSHIP NETWORK, Inc..
The principal place of business of this corporation shall be 1255 Cobia Ct., Naples, FL. 34102

ARTICLE II. NATURE OF BUSINESS

This corporation may engage in the business of counseling companies who sponsor events of national significance, of making and assisting in such arrangements as will be needed for their personnel, guests, etc., and providing all services necessary to such companies. In addition, the corporation may engage in and transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having no par value.

ARTICLE IV. ADDRESS

ARTICLE V. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI. SPECIAL PROVISION

It is the intent of the incorporator that the corporation will qualify as an S corporation under the Internal Revenue Code. Such actions as are necessary will be taken by the appropriate officers to accomplish this compliance.


ARTICLE IX. INCORPORATOR

These Articles may be amended by the Sole Shareholder and Director, or by a majority vote of the Directors and Shareholders, if more than one.




