The street address of initial registered office of this corporation is 7445 Prescott Lane and the name of the initial registered agent of this corporation at that address is ANN WOOLARD.

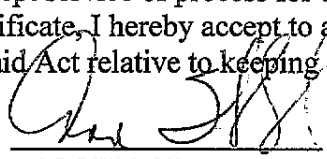
