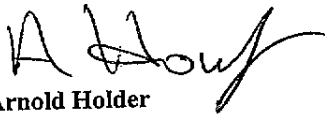

OF

The undersigned files these articles for the purpose of forming a corporation under Chapter 607, Florida Statutes, 1983, and certifies as follows:

ARTICLE I

The name of the corporation shall be **The Spectrum Group on the Gulf Coast, Inc.**

ARTICLE II

The purpose for which the corporation is organized is to transact any and all legal businesses for corporations to be engaged in pursuant to Chapter 607, Florida Statutes, 1983. The corporation's existence shall be perpetual.

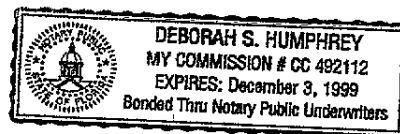
