ARTICLE IX - AMENDMENT

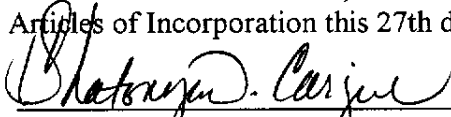
