ARTICLES OF INCORPORATION

AAA LONE STAR CONCRETE PUMPING INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the State of Florida, by and under the provisions of the Statutes of the said State of Florida.

ARTICLE 1

The name of the corporation shall be:

ARTICLE 11
