**ARTICLES OF INCORPORATION
OF

ARTICLE I

NAME

The name of this corporation is: **CARIDAD MUSIC CORPORATION**

ARTICLE II

DURATION

The period of duration of this Corporation is perpetual.

ARTICLE III

PURPOSES AND POWERS

This Corporation may engage in any activity of business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

CAPITAL STOCK

The aggregate number of shares which this Corporation shall have authority to issue is One Million (1,000,000) shares of Common Stock, having no par value.

ARTICLE V

PRE-EMPTIVE RIGHTS

Every stockholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares), at the price at which it is offered to others.

ARTICLE VI

DATA RESPECTING DIRECTORS

7.1 Initial Board of Directors

ACTION BY DIRECTORS AND STOCKHOLDERS WITHOUT A MEETING


The Directors and Stockholders of this Corporation may take action by written consent, as provided by law and the By-Laws of this Corporation.




