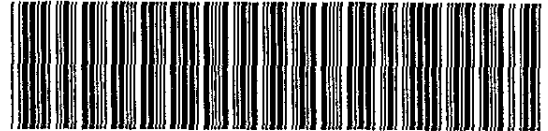

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is **FITTING IMAGE, INC.**
2. The following amendment to the articles of incorporation was adopted by the directors of the corporation on January 26, 2005, in the manner prescribed by the Florida General Corporation act:

ARTICLE I

NAME

The name of the corporation shall be **COASTAL ELEMENTS, INC**, effective immediately.

3. There were no shares outstanding at the time of such adoption and this amendment was adopted by a unanimous vote of the shareholders and directors of the corporation.


4. The amendment does not effect a change in the amount of stated capital.
