# ARTICLES OF INCORPORATION

TOP GUNZ RENOVATIONS, INC.

I, the undersigned, hereby subscribe to, acknowledge and file the following Afticle

of Incorporation, for the purpose of creating a corporation under the Laws of the State of Florida.

#### ARTICLE I - NAME

The name of this corporation is:

TOP GUNZ RENOVATIONS, INC., a Florida corporation.

# ARTICLE II- PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business for which a corporation may be incorporated under Chapter 607 Florida Statues.

## <u>ARTICLE III - CAPITAL STOCK</u>

This corporation is authorized to issue 100 shares of no par value common stock, which shall be designated as "Common Shares." All of said stock shall be payable in cash, property (real or personal) or labor or services in lieu thereof at the just valuation to be fixed by the Board of Directors.

#### ARTICLE IV - VOTING

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares, with one vote to be cast per share.

## ARTICLE V - TERM OF EXISTENCE

This Corporation shall have perpetual existence.

## ARTICLE VI - STATUS

This corporation elects Sub-Chapter "S" status according to applicable State and Federal Laws and will file a Form 2553 with the Internal Revenue Service.

# **ARTICLE VII - TERMS**

This corporation shall commence at the time of filing of these articles and shall have perpetual existence.

## **ARTICLE VIII - PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the prices at which it is offered to others.

#### ARTICLE XII - INDEMNIFICATION

Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of this corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereor. Any director of this corporation who is also a director or officer of such corporation, who it is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation.

# **ARTICLE XIV - BY LAWS**

The Board of Directors of this corporation may provide such By-Laws for the conduct of the business of the corporation and the carrying out of its purposes as such Directors may deem necessary from time to time.
