**ARTICLE ONE**

The name of this corporation is REMARKABLE SPARKLE, INC. and the mailing address of the corporation shall be 5167 Sunny Brook Court, Cape Coral, FL 33904.

**ARTICLE TWO**

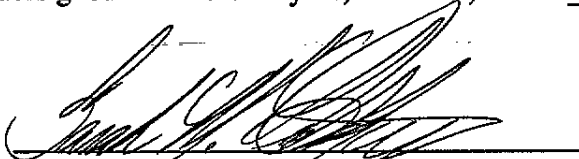

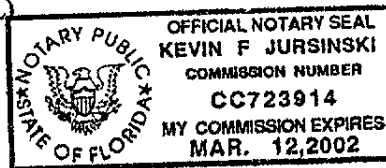

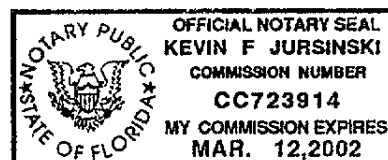
