ARTICLES OF INCORPORATION

OF

REMARKABLE SPARKLE, INC.



ARTICLE ONE

The name of this corporation is REMARKABLE SPARKLE, INC. and the mailing address of the corporation shall be 5167 Sunny Brook Court, Cape Coral, FL 33904.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.
