**ARTICLES OF INCORPORATION OF GLOBAL
MACHINERY AND SERVICES INC.**

We the undersigned, hereby associate ourselves together for the purpose of forming a corporation for profit under the Laws of the State of Florida provided for the formation, liability, rights, privileges and the immunities of a corporation.

ARTICLE I: NAME AND ADDRESS

The name of the corporation shall be GLOBAL MACHINERY AND SERVICES, INC. It's principal mailing address shall be 110 N. Armenia Avenue, Suite B, Tampa, Florida 33609.

ARTICLE II: PURPOSES

1. To enter into and make and perform and carry out contracts of any kind and description made for any lawful purposes, without limit to the amount, with any persons, firm, association or corporation, either public or private, or with any territory, government or agency thereof.
2. To manufacture, buy or otherwise acquire, own, mortgage, sell, assign, transfer, or otherwise dispose of, or deal or trade in, and with, goods, wares, and merchandise and articles of commerce.
3. To borrow money, to draw, make, accept, endorse, transfer, assign, execute and issue any bonds, debentures, promissory notes and other evidences of indebtedness and for the purpose of securing any of its obligations or contracts, to convey, transfer, assign, deliver, mortgage and/or pledge all or any part of the property or assets at any time owned or held by this corporation, upon such terms and conditions as the Board of Directors shall authorize, and as may be permitted by law.
4. To acquire, hold, sell, reissue or cancel any shares of its own capital stock, provided however, that this corporation may not use any of these funds or property for the purchase of its own shares of capital stock when such use would cause an impairment of the capital of the corporation.
5. To transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
6. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

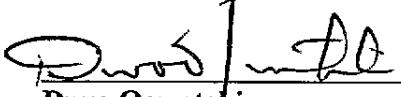

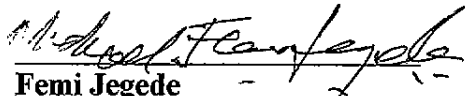
