ARTICLE I



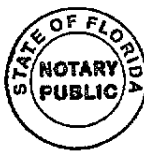
