

ARTICLES OF INCORPORATION

OF

BOOTLE BAY BUILDING, CONTRACTING & CONSTRUCTION MANAGEMENT SERVICES, INC.

ARTICLE I - NAME

The name of this corporation is Bootle Bay Building, Contracting & Construction Management Services, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these articles of incorporation.

ARTICLE III - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one thousand (1,000) shares of one dollar (\$1.00) par value common stock, which shall be designated "Common Shares".

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, in accordance with the provisions of the Florida Business Corporation Act.


ARTICLE XIII - AFFILIATED TRANSACTIONS
