### ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

## PARROT RIVER TRADING COMPANY, a Florida corporation



Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is PARROT RIVER TRADING COMPANY (hereinafter called the "Corporation").
- 2. Article III of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced with the following new Article III:

#### "ARTICLE III CAPITAL STOCK

The maximum number of shares that this Corporation is authorized to have outstanding at any one time is 1,000,000 shares of common stock having a par value of \$.001."

- 3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
- 4. The amendment made herein to the Articles of Incorporation of the Corporation was adopted by the Unanimous Written Consent of the shareholders and directors of the Corporation as of the date of these Articles of Amendment, pursuant to Sections 607.0704, 607.0821 and 607.1003 of the Florida Business Corporation Act. The number of votes cast for the Amendment was sufficient for approval.
- 5. The effective date of this amendment shall be upon the filing of these Articles of Amendment.
