Pursuant to Section 607.1006, Florida Statutes, the undersigned officer, being duly authorized, empowered and directed to act, hereby files this First Amendment to the Articles of Incorporation of Palm Beach County Bank (the "Corporation") and hereby certifies the following:

- 1. The name of the Corporation is "Palm Beach County Bank".
- 2. The original Articles of Incorporation of the Corporation were filed with the Florida Department of State on August 9, 1999.
- 3. Article Three of the original Articles of Incorporation shall be and hereby is amended by replacing Article Three in its entirety to read as follows:

<u>THREE</u>: This Corporation is authorized to issue two million (2,000,000) shares of common stock, par value Five and 60/100s Dollars (\$5.60) per share.

- 4. This Amendment has been adopted as of July 27, 2000.
- 5. This Amendment was approved by the shareholders of the Corporation. The number of votes cast for the amendment was sufficient for approval.
- 6. Except as amended by this First Amendment, the Articles of Incorporation of the Corporation are hereby adopted and restated as set forth in the original Articles of Incorporation.
