In compliance with the requirements of F.S. Chapter 600 the undersigned, JODI HAUBNER, being a natural person, does hereby as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business Corporation.

ARTICLE I

The name of the Corporation is J.H. REALTY, INC.

ARTICLE II

The existence of the Corporation shall begin upon the filing and acceptance of these articles by the Secretary of State of the sovereign State of Florida.

ARTICLE III

The street address of the initial principal office of the corporation and the initial mailing address of the Corporation is also 820 West Lake Mary Boulevard, # 101, Sanford FL 32773.

ARTICLE IV

The maximum number of shares of stock that this company is authorized to issue and have outstanding at any one time is 100 shares of voting common stock having a par value of One Dollar per share.
